3. GINCANA MECHANICS AND PRICING

This fun activity consists of 30 challenges for families with children under the age of 13. They must excel if they want to obtain famous gifts! They will name Little Detectives by Torredembarra'. All the tests will be explained in a brochure that will be published and distributed by the Ministry of Tourism. The activity starts on March 1 and children will have a maximum of 40 challenges/tests. Depending on the number of tests performed, the may have the following awards that would be distributed as follows:

10 challenges achieved: Three-in-a-row game or Torredembarra's puzzle or tale children's Walk in Torredembarra with the aroma of rosemary.

20 challenges achieved: Torredembarra cup + children's fairy tale
